Planning for a cyber incident

Cyber attacks can significantly impact a business, whatever the size or sector. Organisations should plan for cyber incidents as part of general risk planning. Putting in place a cyber incident response plan gives you a better change of mitigating the impact, helping to restore systems quickly and minimise business downtime.

- Contact your bank or building society and speak to their fraud department.
- Your bank will not ask you to reply to an e-mail
 with personal information, or details about your
 account. If you contact them, use a phone
 number/email address you have found
 yourself, rather than one sent to you in the email –
 it may be false.
- You can check your credit reference file online. You should follow up on any unexpected or suspicious results.
